Promoter

Address: Star City, Watson Road, Birmingham B7 5SA. Genting Casinos UK Limited are licensed and regulated by the UK Gambling Commission.

Slots Tournament

1. Promotion Starts Monday 17th February 2020
2. Promotion Ends Tuesday 31st March 2020
3. Tournaments run every Monday & Tuesday during the promotional dates
4. Tournaments will commence as follows
 - Every Monday & Tuesday within the promotion dates.
 - Times: 6:30pm to midnight
5. Each tournament is FREE to enter
6. Players are free to enter each tournament session, but are only permitted to enter a maximum of 6 times per day. Once between each of the following times; 6:30-7pm, 7pm-8pm, 8pm-9pm, 9pm-10pm, 10pm-11pm and 11pm-Midnight.

 - Redeemable from the Rewards Kiosk from 6:30pm – 23:55

21. The casino operator will determine the allocation of players within each tournament session
22. Each player session lasts for 3 minutes or until the player run out of credits (whichever comes first).
23. Each participating player will start with 50 Non-negotiable credits, which carry no cash value and are solely for the purpose of the tournament. Maximum bet per spin allowed is 50p
24. After each player's session their remaining credit will be recorded by the slots host.
25. The player with the highest score at the end of each tournament will be declared that tournament winner
26. Tie Break-in the event of a tie for 1st place, the prize money associated with 1st place will be divided equally between the players who have scored identically.

Conduct of Play

27. The on Duty Manager may disqualify any player who fails to comply with these terms and conditions or whose behaviour is assessed as being detrimental to the integrity or the proper conduct of the tournament, including but not limited to the following examples:
 - Abuse of casino employees, either verbally or physically
 - Abuse of other entrants, either verbally or physically
28. Where a player does not take an allotted seat at the specified times as nominated by the on Duty manager then the player shall forfeit his/her place in the tournament
29. In the event that a feature is activated prior to the end of the tournament session then the feature will be played out in its entirety and any points earned will count towards the player's final total.
30. In the event of a tournament machine malfunction, the game for that player will become void. If the malfunction of the machine can be resolved, then the effected player may re – enter. If the malfunction of the machine cannot be resolved, the tournament cannot continue and all scores for that session will be void. Players will be able to re – enter the next available tournament session.
31. Any disputes must be raised immediately with the on Duty Manager
32. Events may occur that render the tournaments impossible due to reasons beyond the control of Genting Casinos
33. Any disputes arising from these Terms and Conditions or not covered by the provisions of these Terms and Conditions, the decision of the Duty Manager will be final subject to the Dispute Policy
